Contingency plans for out of hours/holiday cover for inspections and replacement parts being investigated. Cllrs have all been sent training video.

CCTV

Waiting for confirmation from DBC whether it is now operational. DBC to arrange the statutory notices and ongoing monitoring. DBC chased for Cllr visit to control room. 5/10 still no response from DBC 21/10 still no response. Further email sent advising that defibrillator now installed.

Works to Bunkers Lane Playpark (Benches/Bins Etc.)

Clerk to progress outstanding matters including signage. Resi-D timber test showed no faults of major concern. Report to follow. This project will be progressed now that the defibrillator project is finished.
